## **UPDATE ON METERING PROJECT**

Power Superintendent Gary Hatch updated the Board on the Metering project. Last Month, 2, 132 meters had been installed. As of February 5, 2019, 2,942 meters have been installed. Multiple crews have been working on this project. With warm weather and power projects needing to be accomplished the meter installs will more than likely become a lower priority. They will still be installed just at a slower pace. Estimated project completion will be September –October 2019.

One issue that was found was a temperature issue. When investigated a meter lug was found to be loose causing the issue. This was a customer service incident that was simple to solve. Power Superintendent Gary Hatch also brought up the mailer that was sent out by a private company to residents. This matter was turned over to the City Legal Department. Co-Chairman Alan Farnes pointed out to the new members that if 3 or more members meet together that it is considered a quorum. If that happens it needs to be posted as a meeting. He just wanted them to be aware of this and to be careful when it comes meeting together.
