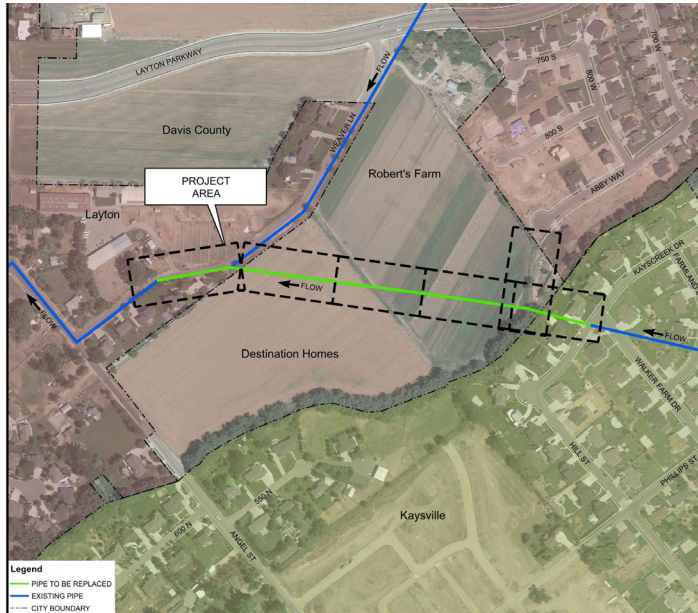




Sewer Line Pipe Replacement between Kayscreek Road in Kaysville City and Weaver Lane in Layton City

Construction between Kayscreek Road and Weaver Lane is scheduled to begin this winter and continue into early spring 2018.



Quick Facts

- What:** Construction of a new sewer line.
- Where:** Through farming fields between Kayscreek Road and Weaver Lane.
- When:** Construction is anticipated to start early February and continue into Spring 2018.
- Why:** The sewer system is in poor condition and an upsized line is needed to meet the additional capacity in the area.

Background and Need

It was determined that the existing 21-inch sewer is in poor condition and does not provide the capacity needs for the population in the area. The main approach to handle the higher capacity needs for the sewer in the area is to upsized the existing line from 21-inch to 30-inch by removing and replacing with a new pipeline.

Replacing the existing sewer line ensures NDSD, Layton City, Kaysville City, and Davis County will continue to provide reliable sewer service that their customers and residents expect. Completing this project prior to the construction of the Destination Homes development will reduce the amount of future disruption and likelihood of problems after the development is completed.

This is part of an overall effort to upgrade and improve the sewer in Layton City and Kaysville City. This improved infrastructure will support and foster economic development in the area.

Safety

Safety is a top priority for the North Davis Sewer District. We encourage and appreciate neighborhood participation to keep children away from the construction equipment and work areas. Parents, please talk with your children about staying away from potentially dangerous construction and watching for construction vehicles.

Frequently Asked Questions

- Q** Will there be any service interruptions to water, sewer or other services during construction?
A No, water and sewer services will not be interrupted.
- Q** I live on Kayscreek Drive or Weaver Lane, will driveway access to my house be open?
A Yes, all driveway access will be maintained throughout construction. The construction may pass in front of a home or business driveway but access will be maintained.
